# Dip in mobile user base not a cause of worry: Trai chief

to allay any concern on the

headline subscriber numbers.

PRESS TRUST OF INDIA New Delhi, June 2

THE RECENT DROP seen in the mobile subscriber base is not a cause of worry nor does it call for the regulator's intervention as fluctuation is on account of multiple factors like minimum recharge plans and will correct in due course, Trai chairman R S Sharma said.

India's total wireless subscriber base fell to 1,161.8 million on March 31, 2019, shedding 21.87 million users over the previous month, according to data released by the Telecom Regulatory Authority of India (Trai) recently. The overall teledensity in India declined to 90.11 at the end of March from 91.86 in February.

"These are fluctuations which happen due to

multiple factors, like telecom operators have started monthly minimal recharge to keep the connections live...that could have led to inactive connections getting removed. These are minor variations which I don't think are major fluctuations, and I don't think it is a cause for worry," Sharma said.

Asked if the regulator intends to intervene to contain the situation, he said, "There is no question of intervening".

"The way data services are being used by the people, I am sure this market is not going to stop. The fluctuation in numbers are due to multiple factors so these corrections, they take place due to certain factors. They are not a matter of concern," he emphasised.

Mobile subscriber base of Vodafone Idea and Bharti Airtel shrunk by nearly 14.5 million and 15.1 million, respectively, as of March (over the previous month) while Reliance Jio added 9.4 million users in the month, according to the Trai data.

"Total wireless subscribers declined from 1,183.68 million at the end of Feb-19 to 1,161.81 million at the end of Mar-19, thereby registering a monthly decline rate of 1.85%," it said.

The wireless subscription in urban areas declined to 650.49 million in March-end from 656.57 million in February-end, and rural user base also plunged to 511.32 million from 527.11 million during the period.

# Hero MotoCorp May sales up 13.5% to over 6.5 L units



**COUNTRY'S LARGESTTWO-WHEELER** maker Hero Moto-Corp Sunday reported 13.5% rise in sales to over 6.5 lakh units in May over the previous

The company had sold about 5.7 lakh units in April 2019, it said in a BSE filing.

"Hero MotoCorp reported sales of 652,028 units of motorcycles and scooters in the month of May 2019. The company recorded a sequential increase in sales compared to the previous month (April 2019) when it sold 574,366 units of two-wheelers," the filing said.

It added that the company had surpassed the six-lakh Hyundai exported 16,600 units in May 2019 as against units mark in monthly sales for the first time since February 11,008 units in the same month last year, an increase of 2019, when it had sold 617,215 units of motorcycles



and scooters.

Last month, Hero Moto-Corp launched three new motorcycles — XPulse 200, XPulse 200T and Xtreme 200S. Apart from these, it had also launched two scooters — Maestro Edge 125 and Pleasure+ 110.

"The bookings for most of these new products have already commenced at Hero MotoCorp dealerships across the country," the statement said.

### SpiceJet to hire up to 2,000 Jet staff, says CMD Ajay Singh **MANOJ RAMMOHAN** continue to take more Jet staff

Seoul, June 2

**SPICEJET PLANS TO** hire up to 2,000 staff, including pilots and cabin crew, of the defunct Jet Airways as the no-frills carrier continues to expand its operations. The airline has taken at least 22 planes that were earlier used by Jet Airways, which temporarily shuttered its operations due to cash crunch in April.

"We have taken significant number of people from Jet Airways. They were well qualified ad professional people. We will

in the times to come.

"We have taken around 1,100 people so far. Expectation is that we will go up to 2,000 people. It will be pilots, cabin crew, (people) from airport services, security...," Spice-Jet chairman and managing director Ajay Singh said in an interview here.

Currently, SpiceJet has around 14,000 staff and a fleet of 100 planes. It is the fourth airline after Air India, now defunct Jet Airways and IndiGo to have 100 aircraft.

SpiceJet has Boeing 737s,



Bombardier Q-400s and B737 freighters. It operates around 575 daily flights on an average to 62 destinations, including nine international ones, he said. To a query on whether SpiceJet would look at operat-

# With Jet being non-operational, opportunities narrowing in India, says Star Alliance CEO



**MANOJ RAMMOHAN** Seoul, June 2

**INDIA IS A** big aviation market and Air India provides the important domestic network for our members but opportunities in the market are narrowing with Jet Airways being nonoperational, Star Alliance CEO Jeffrey Goh said on Sunday. Star Alliance is a grouping of 28 airlines, including Air India, which became a member in July 2014.

Emphasising that Air India is an important representation for the alliance in the Indian sub-continent, Goh said the airline provides very important domestic network for its members to connect into.

"Indian market is a big market and is a very fast growing market... clearly things are changing very fast in the Indian market in connection with what has happened with Jet Airways. I think certainly to that degree possible, it will help

(that)...Air India will have higher capacity and better yields because there is less capacity in the market," he said here.

Full service carrier Jet Airways temporarily suspended operations in April after running out of cash. To a query on whether there could be a second Indian carrier such as low cost carrier IndiGo as a Star Alliance member, Goh said the grouping is positioned for having a full member as well as a connecting partner model.

"We also have the ability to integrate less traditional airlines whether they are hybrid, regional or low cost airlines. We are positioned to address both the situations. We are not closed for business, whether an airline in India is interested in  $full\,membership\,or\,connecting$ partner model. It is more a question of value proposition that you can bring to the network," he said. — PTI

## Bharti Infratel, **Indus Towers** merger gets **NCLT** nod

THE NATIONAL COMPANY Law Tribunal has approved the planned merger of tower company Bharti Infratel with Indus Towers, according to a

regulatory filing. "...National Company Law Tribunal (NCLT), Chandigarh Bench, vide its order dated May 31, 2019, has sanctioned the scheme of amalgamation and arrangement between Indus Towers (Transferor Company) and Bharti Infratel Ltd (Transferee company) and their respective shareholders and creditors...." Bharti Infratel said in a BSE filing.

The proposed merger, which will create a mega tower company in India, will also require approval from the telecom department.

"The scheme shall become effective on the date on which certified copy of the order of...NCLT is filed with Registrar of Companies upon fulfillment/waiver of other conditions prescribed in the scheme. The effective date will be communicated to the stock exchanges for further public dissemination as and when the scheme becomes effective," it said. — PTI






